

**15th ANNUAL MARK NEEDY MEMORIAL
ADULT / YOUTH
HANDICAP DOUBLES TENPIN TOURNAMENT**

1. THE 15th ANNUAL MARK NEEDY MEMORIAL ADULT / YOUTH HANDICAP DOUBLES TOURNAMENT IS OPEN TO CURRENT MEMBERS OF THE UNITED STATES BOWLING CONGRESS. 42 TEAMS MAXIMUM
2. THE TOURNAMENT WILL BE HANDICAP - 95% OF THE DIFFERENCE OF THE HIGHEST TEAM AVERAGE ENTERED IN THIS TOURNAMENT. A TEAM WILL CONSIST OF ONE (1) ADULT & ONE (1) YOUTH BOWLER. **YOUTH BOWLERS WILL USE THEIR HIGHEST 2017-2018 AVERAGE OF 21 GAMES OR MORE. YOUTH BOWLERS WHO DO NOT HAVE A 2017-2018 AVERAGE OF 21 GAMES OR MORE WILL USE THEIR HIGHEST CURRENT 2018-2019 AVERAGE OF 21 GAMES OR MORE AS OF 12/01/18. YOUTH BOWLERS WHO DO NOT HAVE A 2017-2018 AVERAGE OF 21 GAMES OR MORE OR CURRENT 2018-2019 AVERAGE OF 21 GAMES OR MORE AS OF 12/01/18 MAY BOWL USING 220 AS AN ENTERING AVERAGE. ADULT BOWLERS WILL USE THEIR HIGHEST 2017-2018 AVERAGE OF 21 GAMES OR MORE. ADULT BOWLERS WHO DO NOT HAVE A 2017-2018 AVERAGE WILL USE THEIR HIGHEST CURRENT AVERAGE OF 21 GAMES OR MORE AS OF 12/01/18. ADULT BOWLERS WHO DO NOT HAVE A 2017-2018 AVERAGE OR CURRENT AVERAGE OF 21 GAMES AS OF 12/01/18 MAY BOWL USING 240 AS AN ENTERING AVERAGE. ALL BOWLERS ENTERING THIS TOURNAMENT NOT USING A CURRENT AVERAGE FROM TURNER'S DUAL LANES MUST SHOW PROOF OF THEIR AVERAGE UPON CHECKING IN OR WILL USE 240 AS AN ENTERING AVERAGE. IT IS THE BOWLERS RESPONSIBILITY TO PROVIDE PROOF OF HIS / HER AVERAGE. BOWLERS MUST NOTIFY THE TOURNAMENT DIRECTOR IF THEY ARE USING A MODIFIED HOUSE, CHALLENGE OR SPORT LEAGUE AVERAGE AS AN ENTERING AVERAGE. MODIFIED HOUSE, CHALLENGE / SPORT AVERAGES WILL BE ADJUSTED USING THE USBC CONVERSION CHART. ANY / ALL BOWLERS WHO FALSIFY THEIR AVERAGE WILL BE DISQUALIFIED. RULES 319b, 319c & 319e WILL APPLY TO THIS TOURNAMENT. ANY BOWLER / TEAM THAT MADE THE TOP 5 FINALS IN TWO (2) DUAL LANES ADULT / YOUTH TOURNAMENTS IN 2017-2018 IS / ARE SUBJECT TO RE-RATING BY THE TOURNAMENT DIRECTOR.**
3. TEAMS WILL BE ASSIGNED THEIR STARTING LANE.
4. EACH BOWLER WILL BOWL FOUR (4) GAMES IN QUALIFYING.
5. BOWLERS WILL CHANGE LANES AFTER EACH QUALIFYING GAME.
6. THE TOP FIVE (5) TEAM TOTALS w/ HANDICAP FROM QUALIFYING WILL BOWL A STEPLADDER FINAL WITH/ HANDICAP. THE FIFTH (5th), FOURTH (4th) AND THIRD (3rd) PLACE QUALIFIERS WILL BOWL ONE (1) GAME WITH THE WINNING TEAM ADVANCING TO THE SEMI-FINAL MATCH. THE WINNING TEAM OF THE SEMI-FINAL MATCH WILL BOWL THE TOP QUALIFYING TEAM FOR THE CHAMPIONSHIP. IF THERE IS A TIE THAT WOULD RESULT IN MORE THAN FIVE (5) QUALIFYING TEAMS, A 9th & 10th FRAME w/ HANDICAP WILL BE BOWLED BY EACH TIED TEAM TO BREAK THE TIE. *IF A TIE RESULTS IN QUALIFYING, A 9th & 10th FRAME w/ HANDICAP WILL BE BOWLED BY EACH TIED TEAM TO DETERMINE STARTING POSITION. *THIS ONLY APPLIES IF THE TIE IS BETWEEN FIRST & SECOND / SECOND & THIRD PLACE POSITIONS.
7. PRIZE RATIO: AT LEAST 1 to 10. THE TOP FIVE (5) TEAMS FROM QUALIFYING WILL RECEIVE AN AWARD FROM ALADDIN AWARDS.
8. ALL BOWLERS MUST SHOW THEIR U.S.B.C. CERTIFICATION CARD WHEN CHECKING IN.
9. BOWLERS MUST CHECK IN TOGETHER AND SHOULD CHECK IN AT LEAST THIRTY (30) MINUTES BEFORE THE SCHEDULED STARTING TIME OF 9:30am.
10. TARDY BOWLERS WILL NOT BE PERMITTED PRACTICE BALLS AND GIVEN A ZERO (0) FOR EACH FRAME MISSED. BOWLERS WHO ARE NOT AT THE BOWLING CENTER BY THE SCHEDULED STARTING TIME OF 9:30am CAN BE REPLACED BY A SUBSTITUTE BOWLER WITH NO REFUND.
11. ENTRIES WILL OPEN NOVEMBER 11, 2018 AND ARE NON-TRANSFERABLE. **NO TELEPHONE RESERVATIONS. NO FAXED ENTRIES. CREDIT CARDS CAN NOT BE ACCEPTED BY TELEPHONE.**
12. ENTRY FEE PER TEAM WILL BE \$25.00 - \$12.50 BOWLING FEE, \$7.50 PRIZE FEE, \$1.00 EXPENSE FEE & \$4.00 DONATED TO THE DUAL LANES SATURDAY MORNING YOUTH TENPIN LEAGUE.
13. WALK-IN'S WILL BE ACCEPTED FROM 8:30am - 8:45am IF AVAILABLE.
14. ENTRY FEE MUST ACCOMPANY ENTRY FORM. NO REFUNDS
15. THE TOURNAMENT WILL START PROMPTLY AT 9:30am. PRACTICE WILL BEGIN AT 9:20am. PRACTICE BALLS WILL NOT BE PERMITTED BETWEEN QUALIFYING GAMES.
16. MAKE CHECKS PAYABLE TO TURNER'S DUAL LANES. THERE WILL BE A \$25.00 FEE, PLUS ANY ASSESSED BANK CHARGES FOR RETURNED CHECKS.
17. U.S.B.C. RULES WILL GOVERN IN THE ABSENCE OF TOURNAMENT RULES.
18. TOURNAMENT MANAGEMENT HAS THE RIGHT TO REFUSE ANY ENTRY.
